Native Americans are not a people. They are many peoples. There are over 500 federally recognized tribes in the United States and approximately 200 Native American languages are still spoken in North America today. The richness, beauty, ways of life and beliefs of these diverse Native American cultures have much to teach us. Jean Red Raven Kilian, a Mi'kmaq Native American and GCNC member, will take us into the world of Native American cultures and traditions, and explore the arts, crafts, dress, customs, beliefs and legends of Native American peoples. Dressed in full regalia, Jean will demonstrate and explain various Native American objects and artifacts. She will tell us how she got her name and how names are given in native cultures. What is a tribe and how do the many Native American tribes differ? What is family life like in Indian cultures? How do Native American cultures view the Earth and nature? This will be an entertaining, enriching and enlightening program that will focus not only on the values of Native American cultures, but on the meaning those values have for us all.

Common to each yard were many feeders of various types. Sunflower seeds, millet, corn, peanuts, peanut butter, thistle seed and several kinds of suet were being used to attract the different species. Good shelter and water were also provided. Some folks had heated birdbaths or running water for their birds. I hope that the other club members who made the trip were as inspired as I was to put up more feeding stations.

## **Conservation Corner – Radioactive Dump in Our County?** by Loretta Dunne

New Jersey has no radioactive waste dumps and the state hopes to keep it that way. The state has filed a lawsuit against the Nuclear Regulatory Commission to stop them from reviewing and approving a plan to allow Shieldalloy Metallurgical Corp., centered in Swedesboro, from burying more than 50,000 tons of radioactive slag and dust in its backyard.



The company wants to close its operation in Newfield, Gloucester County and continue business more cheaply with a sister company in Brazil. For more than 40 years, the metal-making factory in [Newfield, Gloucester County](#), has thrown its trash out back, creating a six-acre, 35-foot-high pile of radioactive rock called slag, according to Monica Yant Kinney of the Philadelphia Daily News on September 23, 2006

They claim that a full cleanup of the site would cost \$58 million. For more than 40 years, the company has thrown its trash out back, creating a six-acre, 35-foot-high pile of radioactive slag. They claim that burying it, fencing off the property and monitoring the area for 1000 years would cost about \$5 million. I don't need to remind you how ineffective tracking of toxic sites have been to date in New Jersey. This plan is simply unfeasible.

The Department of Environmental Protection is opposed to the plan and says it presents a threat to the groundwater and public health.

Most of our elected officials oppose this plan, including Governor Corzine, Senator Menendez and Senator Lautenberg.

Please contact your elected officials and support the lawsuit against NRC. Also, contact NRC and let them know what you think of allowing a company to operate 50 years in New Jersey and not be responsible for their radioactive wastes:



### **Cumberland County Winter Eagle Festival**

On Saturday, February 3, Cumberland County, NJ will be hosting its annual Winter Eagle Festival (formerly known as the Raptor Festival). This is a great chance to see Hawks, Vultures, and Eagles, and there are plenty of knowledgeable volunteers around to help you spot and identify them.

The Festival will start with a 7am Sunrise Walk at Turkey Point, lead by NJ Audubon's Pete Dunne. Various viewing sites will be staffed by the NJ Audubon Society and Cape May Bird Observatory from 10am to 5pm. At 5pm, Pat Sutton will lead a Sunset Owl Watch at Turkey Point. There will also be exhibits, lectures, and food in the Mauricetown Fire Hall from 8am to 4pm. Natural Lands Trust will be one of the exhibitor - be sure to stop by and say hello! Lecture topics include: "Endangered and Nongame Species Program," "The Crucible of Migration," "Identifying 'em Far, Far Away," "How to Spot an Owl," and "Raptors of the Bayshore."
