

Field Trip – Conowingo Dam Sunday March 11thth, 8:00 AM until mid-afternoon Trip Leader: Bob Duke (856) 848-7012

Join us on a field trip to Conowingo Dam, which straddles the Susquehanna River near Port Deposit, MD. Possible sightings at the dam include bald eagles, osprey, several different types of gulls, cormorant, some early migrants, great blue herons and a few species of ducks.



Meet at the Timberline Shopping Center in Mantua at 8:00 AM in order to carpool. For those who drive directly to Conowingo Dam, we plan to arrive there at about 9:30AM.

Directions to Conowingo Dam:

Take one of the bridges to PA and proceed SOUTH on I-95 through DE and into MD. Take EXIT 93, for Port Deposit/Rt222. Go NORTH on Rt 222 for about 8 miles until you come to the intersection with Rt 1. Turn LEFT onto Rt 1 and go across the dam. After crossing the dam, proceed up the hill and take the first LEFT. Proceed about a mile and make another LEFT turn (a very sharp turn) onto Shures Landing Road. This road goes down to the parking areas at the dam. Bring a lunch or snacks. I plan to be there until early afternoon.

The 2007 Gloucester County Bird Quest: Saturday May 5, 2007

The Gloucester County Nature Club and many area businesses, industries, and local environmental commissions invite people of all ages to participate in the 2007 (eighth annual) Gloucester County Bird Quest. The 2007 Bird Quest will take place on Sat., May 5, 2007 from 7 AM to 12 noon in Gloucester County.

During this time, teams visit parks and natural sites in Gloucester County and find as many different bird species as they can. The Quest is:

- A way to discover Gloucester County's parks and natural areas
- A way to discover the unique birds that live in and through our county
- A chance to learn how to identify birds by sight, sound, behavior, and habitat
- A chance to have fun with friends and colleagues
- A light-hearted competition

The Quest is an educational event: novices are encouraged to participate. At noon, all participants gather at Atkinson County Park on Delsea Drive to report results and for (free) lunch, t-shirts, and prizes.

Most people organize their own Quest team with colleagues, friends, and/or family. Last years Gloucester County Bird Quest attracted several hundred participants made up of teachers, school groups, scout troops, environmental commissions, families, friends... residents of Gloucester and neighboring counties. This year with support from Wheelabrator, LP of Gloucester County, the club will operate two (free) guided buses for teachers and other persons unable to form their own team and who are willing to join a larger group.

This year we are proud to announce that we have our own colorful "Raptors of Gloucester County" T-shirt designed by the club's own Gary Lizzi. A county map and other materials are provided to registered teams. A \$12 fee per participant covers the cost of lunch, T-shirt, prizes etc.

Conservation Corner – 15 Minutes a Week by Loretta Dunne



I frequently read about issues and make plans to contact an elected official or a corporation to express my concerns. In spite of my best intentions, I sometimes find that weeks have gone by without taking actions on any of the issues I planned to address. I am sure that many of you find yourself in the same situation.

Therefore I urge everyone (myself included) to set a goal of one letter a week. Take 15 minutes and a topic that has bubbled up in your list of concerns. If you take 15 minutes once a week and write a letter, by the end of the year, you will have expressed yourself directly to someone of influence 52 times. That is a lot. And knowing that you will put in at least those 15 minutes a week will be reassuring. As involved nature lovers, we owe it to the world around us and to ourselves to set aside a little time dedicated to protecting the earth. Maybe Sunday evening before the week begins is best for you, or early one morning, whatever fits into your life. Having a time slot identified and dedicated to your activism will make you more successful.

Polar Bear Protection by Loretta Dunne

You have until April 9th to send comments in support of classifying polar bears as threatened under the Endangered Species Act. If you write a supporting letter, be sure to indicate that recent evidence has shown that the sea ice habitat is melting due to greenhouse gas pollution. To protect the polar bears, steps must be taken to reduce global warming. Send comments to;

Cloned Food Products by Loretta Dunne

The FDA has completed its review of food from animal clones and will likely approve the sale of cloned foods this year. There will be no labeling required, therefore it will not be possible to determine if a meat or dairy product came from a cloned source. You will not have the freedom to avoid cloned foods. The FDA is now taking comments on this decision. The comments must be received by April 2nd.

There is scientific concern about risks related to food cloning. According to the Organic Consumers Association, "Consumer, food safety, and animal welfare groups have condemned the announcement, pointing out that animal cloning is inherently unpredictable and hazardous, and that the practice of cloning has led to a high number of cruel and painful deformities in the experimental animals' offspring."
