When many of us think of Christmas, we think of traditions big and small which may go as far back as our childhood. The Christmas Bird Count is another tradition that has been a part of



people's lives since 1900. The Christmas Bird Count was started by a newly-formed Audubon Society as an alternative to another Christmas tradition called a "side hunt" which challenged people to kill as many feathered and furry creatures as possible. Learn how Frank Chapman and his colleagues turned a gruesome holiday tradition into one of the longest environmental surveys in existence. Various speakers will explore the history of the Audubon Christmas Bird Count, explain how the Count is conducted, and share some experiences of the Count.

# Field Trip – <u>Audubon Christmas Bird Count</u> Saturday December 17 <sup>th</sup>, Dawn 'til Dusk

Looking for a holiday tradition that doesn't include going to the mall? The Christmas Bird Count may be for you. The Audubon Christmas Bird Count was started in 1900 and the Gloucester County Nature Club coordinates the Gloucester County count. Groups will divide up a 15 mile count circle and census all the birds seen. Many groups will begin or end their day searching for owls, and use the daylight hours to identify raptors, warblers, sparrows, great blue herons, and many other birds. We invite you to join us in this wonderful tradition by joining one of the groups. The starting and ending time for each group is decided by the team organizer(s); generally it is at least dawn to dusk but that will vary by team. The National Audubon Society

requires a \$5 fee of all participants that is used for administrative costs. If you'd like to join the Count, please call Deborah Maka at 856-863-0330.

**Note:** Just because a team starts and ends at a certain time.... Doesn't mean everyone on that team has to do the same. Some teams have participants who come for part of the day (morning or afternoon). Some team leaders prefer that participants stay the whole time. It really depends on the team; please check with the leaders for details.

## Field Trip Report: Avalon Sea Watch and Cape May Hawk Watch (11/05/05) - by Kris Mollenhauer

We stood on the jetty watching long chains of Black Scoters approaching from the north, flying in single file, with their living chain twisting about as they came closer. Through our binoculars, we were looking for a flash of white to identify any White-winged Scoters among them. It was quiet at the Avalon Sea Watch that mild morning. The Gannets were flying low over the waves, sometimes their whole six foot wingspan would disappear behind the rolling surf. It was easy to spot the immature dark gannets from the mature white birds with the black wing tips. Several pairs of common loons passed by from north to south over our heads. Next stop was the Hawk Watch platform at Cape May. Although we did not have the northeast winds that cause a large migration of raptors, we did get to observe a Black-throated Green warbler who was hanging around us for almost an hour. A couple of Ospreys were hovering over the marsh looking for fish in the water below. What a beautiful day to be outside. The peak fall foliage made the ride a pleasure. Our field trip leader Jeff Holt even spotted a pair of Bald Eagles at East Creek Lake on the ride down.
